**Arbor Day Planning**

The annual Arbor Day activity will be held on April 18. It will begin at Shady Creek Nature Sanctuary 3:30 – 5:30 pm for the tree planting. We will then move to the Sculpture Park for the actual event. Scouts will be handling the flag ceremony. Other activities will include the proclamation from the Mayor, presentation of the Trees of Distinction awards by Joanne Fogarty, presentation of the Tree Steward Award and closing ceremony. Yvonne has completed the program, awards have been ordered and work is being done on the proclamation. It was agreed that some GSAC members would bring water and cookies. Jenine Harris will be out of town and not available. Ginger will work on publicizing the event. Yvonne can provide tents if it rains.

**NEW BUSINESS:**

**COUNCIL UPDATE:** Matt Armstrong

\*A reminder was made regarding the election taking place tomorrow and the importance of voting.

\*Councilman Armstrong informed the commission that the City's contract with Meridian Waste is being terminated effective this June. Waste Management will once again handle trash removal for the City. The City has received numerous complaints regarding Meridian Waste and it was decided it was in the best interest of the City to switch to Waste Management, which had submitted the second lowest bid.

**STAFF UPDATE:** Yvonne Steingrubby

\*Staff will be implementing new procedures in their honeysuckle removal efforts at the back side of Larson Park.

\*A comment was made that the spray the trucks use for mosquito control are destroying pollinators. It was clarified that the City itself does not do the spraying. The trucks come from STL County, based on complaints it receives regarding mosquitos. It was suggested that the City adopt a resolution to ban spraying or to opt out of the County program. Yvonne will contact the County to see what the procedure is to opt out and what the options are.
