1. 514 Ridge – Demolition of a 100 Year Old Structure

Although Applicant not present to discuss usual criteria, Mara Perry advised the HPC that staff has conversed with Applicant. HPC members discussed criteria, remarking, noting lack of remarkable historical significance of subject property. Mike McClourey moved to conclude discussion; seconded; motion passed by unanimous vote.

2. <u>Library Historic Photo Contest</u>

Anne Kelly presented information regarding Webster Groves Library Historical Building Photo Contest to the HPC, advising of the library's interest in having the HPC participate in the event. The HPC discussed, agreed that the HPC would be happy to take part in the event. Anne Kelly will communicate and coordinate with Tom Cooper and report back next month.
