COURT ORDER

VIOLATIONS BUREAU SCHEDULE OF OFFENSES AND FINES

THE FOLLOWING FINES ARE EFFECTIVE FOR ANY CITATIONS FROM JANUARY 3, 2020 AND THEREAFTER UNTIL FURTHER NOTICE. HOWEVER, THE COURT FINES ARE SUBJECT TO CHANGE (WITH AN APPEARANCE IN COURT) AT THE JUDGE'S DISCRETION.

IN ACCORDANCE WITH MISSOURI STATUTES AND ORDINANCES ADOPTED BY THE CITY, TOTAL COURT COSTS SHALL BE \$33.50. COURT COSTS SHALL BE PAID IN ADDITION TO THE FINE.

THE WEBSTER GROVES TRAFFIC VIOLATIONS BUREAU IS ESTABLISHED AS A **CONVENIENCE** TO THE PUBLIC. IT IS **NOT** INTENDED TO REPLACE A COURT APPEARANCE FOR **PLEAS OF NOT GUILTY**. IF YOU BELIEVE THAT YOU ARE **NOT GUILTY** OF THE OFFENSE(S) CHARGED, YOU SHOULD APPEAR IN COURT ON THE DATE INDICATED ON YOUR SUMMONS/TICKET/COMPLAINT.

IF YOUR VIOLATION INVOLVED AN AUTO ACCIDENT/CRASH, YOU MUST APPEAR ON YOUR COURT DATE.
